  - Determine what occurred and when it occurred.
  - Recognize where they purposely skipped over information within their language.
  - Identify where to focus questions during the interview.
  - Obtain information the subject has *unknowingly* revealed.
  - Identify what part of the language is *unnecessary* and why it is so important.
  - Understand the nature of the relationship to others in the statement.
  - Recognize major personality traits revealed in the subject's words.
